DECISION ON REQUEST FOR REVIEW


On November 12, 1975 the Executive Director of the Public Employment Relations Commission issued E.D. No. 76-7, constituting his Decision and Direction of Election in the above-captioned representation proceeding. By letter dated November 18, 1975 the attorney for the public employer, Bergen County Board of Chosen Freeholders, stated that the Freeholders would consider E.D. No. 76-7 at a meeting to be held on November 19, 1975 and that in the event the Freeholders chose to file a Request for Review with the Public Employment Relations Commission a short extension of time

would be needed. Thereafter on December 1, 1975 the attorney for the Freeholders mailed to the Commission a Request for Review together with an affidavit of simultaneous mailing of a copy thereof to the attorneys for the above-captioned petitioner and intervenor and to the Executive Director. Neither the petitioner nor the intervenor has filed papers in opposition to the Request for Review.

The Commission having considered the public employer's submissions and upon due deliberation, request for review is hereby granted and, upon review, the Executive Director's Decision and Direction of Election in E.D. No. 76-7 is hereby affirmed substantially for the reasons expressed therein.

The election directed by the Executive Director in E.D. No. 76-7, which has not been conducted because of the filing of the instant request, is hereby directed to be conducted in accordance with the Commission's Rules within 30 days of the date of this decision.
