## MEMORANDUM OF AGREEMENT BETWEEN

## THE ATLANTIC CITY PROFESSIONAL FIRE FIGHTERS IAFF LOCAL 198 AND

## THE CITY OF ATLANTIC CITY

The Atlantic City Professional Fire Fighters IAFF Local 198 and the City of Atlantic City have reached agreement on the terms of a collective negotiations contract to succeed the contract which is due to expire on December 31, 2007. The terms of the new agreement are as follows:

- 1. All provisions of the January 1, 2000 through December 31, 2002 collective negotiations agreement, including all provisions of the interest arbitration award issued by arbitrator James Mastriani in the matter entitled Altantic City Professional Fire Fighters, International Association of Firefighters Local number 198, v. City of Altantic City, docket number IA-2003-086, issued on October 16, 2006, which established the terms and conditions of employment for the collective negotiations agreement covering the period January 1, 2003 through December 31, 2007, which are not modified by this memorandum, are carried forward in this new contract, with changes and dates where appropriate.
- 2. This Agreement shall commence January 1, 2008 and will be continued for a period of five (5) calendar years expiring December 31, 2012. Lin A.D. A.D.

L.1. Four Gp. Effective January 1, 2008 and on each January 1st thereafter for a period of five (5) years an annual wage increase of four (4%) per year will be provided to all members of the bargaining unit, and the salary guides for each year of the contract shall be increased accordingly.

4. Medical insurance will remain unchanged as is currently provided with the exception of: Prescription being at \$10.00 generic and \$15.00 name brand effective January 1, 2008.

5 Effective January 1, 2008, the Local President shall be granted twenty (20) hours A.D. relief time from duty per week with pay in which to conduct Union Business.

- This Agreement is subject to ratification by the membership of the Atlantic City Professional Fire Fighters Local 198.
- 7 All other terms and conditions in the current Collective Bargaining Agreement remain in full force and effect between the parties.
