WHEREAS, the undersigned have heretofore entered into an agreement pursuant to Chapter 303 of the Public Laws of 1968 for the school years of 1975-1976 and 1976-1977; and

WHEREAS, the parties hereto are desirous of entering into an agreement pursuant to Chapter 123 of the Public Laws of 1975 for the school year 1977-1978 and 1978-1979; and

WHEREAS, the parties hereto are desirous of formalizing that agreement by merely adding an addendum to the 1975-1976 and 1976-1977 contract;

NOW, THEREFORE, it is agreed by and between the undersigned parties that the agreement for the year 1975-1976 and 1976-1977 is hereby ratified and confirmed subject to the following modifications and further subject to the modifications of Schedule A of said agreement by the annexing to this addendum of Schedule A covering the salaries to be paid for the year of 1977-1978 and Schedule B covering the salaries to be paid for the year of 1978-1979:

1. Article III is amended so as to delete the reference to Chapter 303 of the Public Laws of 1968 and in its place to refer to Chapter 123 of the Public Laws of 1974.

2. Article V is amended so as to delete the reference to Chapter 303 of the Public Laws of 1968 and in its place to refer to Chapter 123 of the Public Laws of 1974.

3. Article XVIII is amended to change the address of the Association to read:

Section 2, Number 2, as follows:

"If by Board to Association President, the address of the Association President shall be provided to the Superintendent upon the opening of school each year."


3. Article XIX should read as follows:


"The provision of this Agreement shall be effective from July 1, 1977 and shall continue and remain in full force and effect up to and including June 30, 1979."


