## AMENDED AGREEMENT

BETWEEN

# BOROUGH OF WEST LONG BRANCH NEW JERSEY

AND

# WEST LONG BRANCH POLICE DEPARTMENT P.B.A. LOCAL 141

JANUARY 1, 2008 through DECEMBER 31, 2011

# PREAMBLE

This Agreement, made this 19th day of May, 2010, by and between the Borough of West Long Branch, County of Monmouth and the State of New Jersey, hereinafter referred to as "Borough", and the West Long Branch Police Department PBA Local 141, hereinafter referred to as "Police", is designed to AMEND and extend the terms and provisions of the existing 2088-2010 contract until December 31, 2011, the only changes for 2011 being set forth below.

The sections below replace the same numbered sections in the previously signed 2008-2010 contract.

## ARTICLE I

## SALARIES

## SECTION 1.

The base salaries effective January 1, 2010, shall also be the salaries effective January 1, 2011. No other changes to the salary provisions are made.

## ARTICLE XII

# MEDICAL

### SECTION 2.

The Borough agrees to provide health benefits after retirement. This means that the Borough will pay for health benefits under the Direct Access plan, which shall be non-dental in nature, and become effective June 1, 2010. If necessary or required, the Borough further agrees to pass an appropriate resolution effectuating this agreement. This benefit shall accrue to any member of the West Long Branch Police Department who has at least twenty-five (25) years of service. It is understood, however, that if the plan changes again, the Borough shall have the right to purchase an equivalent plan on the same terms as set forth in this section.

## SECTION 3. (new)

Because this contract amendment results in the current contract expiring December 31, 2011, no member of the bargaining

unit shall be required to make any health insurance contribution, from his or her pay, during the term of this contract.

## SECTION 4. (new)

All bargaining unit members will be insured for health purposes under the Direct Access plan effective June 1, 2010.

## ARTICLE XVII

# CONSTRUCTION

#### SECTION 1.

This amended agreement, together with the 2008-201( contract to the extent not modified herein, shall be effective as of January 1, 2008, and expire December 31, 2011.

In the event that a new agreement has not beer reached prior to the expiration date of this agreement the provisions of this agreement, excluding the health insurance contribution provisions, shall continue in force until such new agreement has been reached. That means that, effective January 1, 2012, the members of the bargaining unit will be required to contribute toward their health insurance, from their pay, ir accordance with the laws of the State of New Jersey.

## SECTION 2. (new)

All terms of the 2008-2010 contract which have not been modified herein shall remain in force through December 31, 2011.
