AGREEMENT

In accordance with the provisions of Title 34, Chapter 13A-1, Senate Bill No. 740 effective July 1, 1968, the Board of Education of the City of Asbury Park and the Asbury Park Administrative and Supervisory Association, for themselves, their successors and assigns, hereby mutually agree as follow :

A. The Board of Education of the City of Asbury Park and the Asbury Park Administrative and Supervisory Association have agreed upon a salary guide for the school year 1973-74, a copy of which is annexed hereto and made a part hereof;

B. The parties agree that the said guide was determined by a policy of the Board of Education now in effect to give the administrators twelve month contracts on the basis of the contract negotiated by the Asbury Park Education Association for teachers using the incidence of responsibility guide attached hereto.
