The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included: All regularly employed institutional employees of Atlantic County at the Meadowview Nursing and Rehabilitation Center and the Central Kitchen/Warehouse, including employees in the titles of assistant cook, assistant human services, building maintenance worker, building service worker, clerk driver/stockhandler, cook, dietician helper, environmental therapy aide, food service worker, head cook, institutional attendant (non-cert.), institutional attendant (cert.), laborer, licensed practical nurse, restorative aide, senior building service worker, senior clerk driver/stockhandler, senior cook, and senior institutional attendant.

<u>Excluded</u>: Managerial executives, confidential employees, and supervisors within the meaning of the Act; craft employees, police, casual employees; employees in other negotiations units; and all other employees of Atlantic County.
