The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included : All full-time instructional and professional library staff employed by the Union County College.

Excluded : Managerial executives, confidential employees, police and craft employees, supervisors and all other employees employed by Union County College.
