**CERTIFICATION OF REPRESENTATIVE  
BASED UPON AUTHORIZATION CARDS**

In accordance with the New Jersey Employer-Employee Relations Act, as amended, and the Rules of the Public Employment Relations Commission, we have conducted an investigation into the Petition for Certification filed by the above-named Petitioner. The Petitioner has demonstrated by card check that a majority of the unit employees described below have designated the Petitioner as their exclusive representative for purposes of collective negotiations, and, no other employee organization has expressed a valid interest in representing these employees.

Accordingly, **IT IS HEREBY CERTIFIED** that

**CENTRAL REGIONAL EDUCATION ASSOCIATION**

is now the exclusive representative of all the employees included below for the purposes of collective negotiations with respect to terms and conditions of employment. The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

**UNIT: Included:** All regularly employed full and part-time professional or educational support professional personnel designated as follows: a) classroom teachers, b) guidance counselors, c) child study team members, d) nurses, e) librarians, f) department heads, g) office secretarial or clerical staff, h) custodians, maintenance and grounds, i) paraprofessionals, j) supply clerks, k) television studio production assistant, l) athletic trainer, m) media specialist, n) nurse aide, o) computer network technician, p) interpreter, q) food service workers and cafeteria aides.

**Excluded:** Managerial executives, confidential employees, and supervisors within the meaning of the Act; craft employees, police, casual employees; confidential secretaries, secretary to the superintendent, secretary to the business administrator, payroll secretary, accounts payable secretary, accounts receivable secretary, bookkeepers, supervisors and directors, building principals, vice/assistant principals, coordinators, assistant superintendents, business administrators, athletic directors, transportation coordinators, supervisor of buildings and grounds, food service director; and all other employees of the Central Regional Board of Education.
