Excluded: Managerial executives, confidential employees and supervisors within the meaning of the Act; craft employees, police, casual employees; superintendent, secretary to superintendent/school district executive secretary, business administrator/board secretary, secretary to the business administrator, accounts payable supervisor, bookkeeper, assistant to the board secretary, treasurer of school monies, director of curriculum, principal/vice principal, community edc/rec director, substitute teacher, attendance officer, summer school teacher, supervisor of buildings and grounds, supervisor of special services, and activities coordinator; employees in other existing negotiations units; and all other employees of the Somers Point Board of Education.
