**CERTIFICATION OF REPRESENTATIVE  
BASED UPON AUTHORIZATION CARDS**

In accordance with the New Jersey Employer-Employee Relations Act, as amended, and the Rules of the Public Employment Relations Commission, we have conducted an investigation into the Petition for Certification filed by the above-named Petitioner. The Petitioner has demonstrated by card check that a majority of the unit employees described below have designated the Petitioner as their exclusive representative for purposes of collective negotiations, and, no other employee organization has expressed a valid interest in representing these employees.

Accordingly, **IT IS HEREBY CERTIFIED** that

is now the exclusive representative of all the employees included below for the purposes of collective negotiations with respect to terms and conditions of employment. The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

**UNIT: Included:** All regularly employed Family Operations Coordinators employed by the Camden Board of Education, to be added to an existing unit of paraprofessionals, A&B; media personnel; community school coordinators; district parent coordinators; parent center coordinators; community outreach specialists; van drivers; special investigators; school security officers; attendance officers; clerical aides; food service truck drivers; food service truck driver helpers; food service general workers; food service cooks; assistant cooks; food service stockpersons (formerly depot manager); computer specialists; bus drivers; property officer; technician; website specialist and all secretarial and clerical employees under contract with the District, or on leave from the school district.

**Excluded:** Managerial executives, confidential employees and supervisors within the meaning of the Act; craft employees, professional employees, Secretary to the State Superintendent; Secretary to the District Secretary; secretaries to the Assistant Superintendents and all other employees of the Camden Board of Education.
