The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included : All regularly employed sergeants and lieutenants employed by the Township of Randolph.

Excluded : Managerial executives, confidential employees, and non-supervisory employees; professional employees, craft employees, non-police employees, casual employees, patrolmen, detectives, captains, deputy chief, chief of police, and all others employed by the Township of Randolph.
