The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

**UNIT: Included:** All regularly employed full-time and part-time public safety dispatchers employed by Somerset County.

**Excluded:** Managerial executives, confidential employees, and supervisors within the meaning of the Act; police, casual employees, professional employees, craft employees; and all other employees of Somerset County.
