**AMENDMENT OF CERTIFICATION OF REPRESENTATIVE
FOR CHANGE IN NAME AND AFFILIATION**

An investigation of the petition for amendment of certification in the above-captioned matter was conducted in accordance with the New Jersey Employer-Employee Relations Act, N.J.S.A . 34:13A-1, et seq., and the rules of the Public Employment Relations Commission, N.J.A.C . 19:10-1.1, et seq. The petitioner complied with the necessary requirements and the public employer did not oppose the petition. The Director of Representation grants the amendment of certification.

This amendment does not operate as a certification bar pursuant to N.J.A.C . 19:11-2.8.

Accordingly, the Certification of Representative is hereby amended to certify:

TRANSPORT WORKERS UNION OF AMERICA AFL-CIO LOCAL 220

has met all of the requirements for amendment of certification and is now, in the unit described below, the representative for the purposes of collective negotiations, and has been selected by a majority of the employees of the above-named Employer, in the unit described below, as their representative for the purposes of collective negotiations, and that pursuant to the New Jersey Employer-Employee Relations Act, the representative is the exclusive representative of all the employees in such unit for the purposes of collective negotiations with respect to terms and conditions of employment. The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included : All blue-collar employees employed by the Township of Howell.

Excluded : Managerial executives, police, supervisors within the meaning of the Act, confidential employees, craft employees, Director of Public Works, Road Foremen and Chief Mechanic.
