The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included: All regularly employed professional and non-professional employees of the Hoboken Public Library.

Excluded: Managerial executives, confidential employees, and supervisors within the meaning of the Act; craft employees, casual employees, and police.
