Excluded : Managerial executives and confidential employees within the meaning of the Act; nonsupervisory employees; craft employees, professional employees, non-police employees, casual employees; county investigators and employees above the rank of sergeant of county investigators; and all other employees of the Ocean County Prosecutor's Office.
