**Excluded:** Managerial executives, confidential employees and supervisors within the meaning of the Act; craft employees, non-professional employees, police employees, casual employees; chief executive officer, business administrator, accountants, principals, assistant principals, directors, dean of students; and all other employees of the Marion P. Thomas Charter School.
