**CERTIFICATION OF REPRESENTATIVE
BASED UPON AUTHORIZATION CARDS**

In accordance with the New Jersey Employer-Employee Relations Act, as amended, and the Rules of the Public Employment Relations Commission, we have conducted an investigation into the Petition for Certification filed by the above-named Petitioner. The Petitioner has demonstrated by card check that a majority of the unit employees described below have designated the Petitioner as their exclusive representative for purposes of collective negotiations, and, no other employee organization has expressed a valid interest in representing these employees.

Accordingly, **IT IS HEREBY CERTIFIED** that

UNION COUNTY SUPERVISORS' ASSOCIATION

is now the exclusive representative of all the employees included below for the purposes of collective negotiations with respect to terms and conditions of employment. The representative is responsible for representing the interests of all unit employees without discrimination and without regard to employee organization membership. The representative and the above-named Employer shall meet at reasonable times and negotiate in good faith with respect to grievances and terms and conditions of employment as required by the Act.

UNIT: Included : All regularly employed foreman and supervisors employed by the County of Union in the Department of Parks and Recreation and the Department of Engineering, Public Works, and Facilities Management, including supervisory mechanics, park foremen, general trades foremen, general supervisor mosquito extermination, recreation park maintenance general foreman, General Supervisor Bridge Repair, Supervising Bridge Repairer, General Supervisor Roads, Road Repair Supervisor, Supervising Building Repairer, Supervising Building Service, Supervising Heat & Air Conditioning Mechanic, Supervising Maintenance Repairer, Supervising Plumber, Supervisor Compost Project, Supervisor Mosquito Exterminator, Supervisor Traffic Maintenance, Supervising Painter, Tree Maintenance Supervisor, Supervising Mechanic, Supervising Welder, Maintenance Supervisor Grounds, Supervisor Trades, Yard Supervisor, Sewer Repairer Supervisor, Supervising Carpenter, and Supervising Electrician.

Excluded : Managerial executives and confidential employees within the meaning of the Act; nonsupervisory employees; professional employees, police employees, casual employees; white collar employees, higher level supervisors; and all other employees of the County of Union.
