SYNOPSIS

The Executive Director amends a certification to reflect the fact that the previously unaffiliated employee organization (Faculty Association County College of Morris, Inc.), which was certified October 10, 1974 as the majority representative of the employees in a unit stipulated to be appropriate, has affiliated with the New Jersey Education Association. The membership of the Faculty Association voted to affiliate in a secret ballot election after due notice. There has been a complete transfer of officers and members of the unit.

AMENDMENT OF CERTIFICATION OF REPRESENTATIVE

A duly filed petition (AC-13) was jointly filed by the above-entitled parties to clarify or to amend the Certification of Representative as issued on October 10, 1974.


The Public Employer has indicated that in the event that the Commission determines that the certification should be amended to reflect the affiliation of Faculty Association County College of Morris, Inc. (hereinafter FACCM, Inc.) with the New Jersey Education Association, and certifies that FACCM, Inc., affiliated with the New Jersey Education Association, is the exclusive representative for the purposes of collective negotiations for all unit members described in the certification issued on October 10, 1974, the Public Employer will recognize FACCM, Inc., affiliated with the New Jersey Education Association, as that exclusive representative.

FACCM, Inc., has demonstrated that the membership of the certified representative voted to affiliate with the New Jersey Education Association in a secret ballot election and upon proper notification on February 18 and February 19, 1975. FACCM, Inc.

has also demonstrated that there is continuity of unit composition and that there has been a complete transfer of officers and members of the unit.

In consideration of the entire record, including the above, and in accordance with current Commission practice, an amendment of certification is hereby directed.
