## SYNOPSIS

The Chair of the Public Employment Relations Commission and the Acting Commissioner of Education issue a joint order consolidating for hearing individual petitions before the Commissioner of Education and an unfair practice charge before PERC filed by the employee's majority representative. The Chair and Acting Commissioner further hold that the predominant interest rests with PERC.

#### JOINT DECISION

On November 7, 2008, Emma Alparone, Lisa Kerr, Sherry Kerr, Richard Kolton, Steven Kovacs, Katherine Lazzara, Barbara Mann, Amye Paige McGaheran, Evelyn Mickel, Carla Nowell, Judy Rodgers, Betty Sutton, Kim Erzuolo, Jeffrey Thompson, Gerald Tolomeo and Patricia Tuma filed petitions with the Commissioner of Education appealing the determination of Respondent High Bridge Board of Education, Hunterdon County, to recoup funds allegedly erroneously paid to them under their contracts from 2002-2005 and 2005-2008 by freezing their salaries and withholding increments and other benefits.

On November 24, 2008, the High Bridge Teachers Association filed an unfair practice charge with the Public Employment Relations Commission alleging that the Board violated the New Jersey Employer-Employee Relations Act, specifically N.J.S.A. 34:13A-5.4a(1)&(5) $^{1/}$ , when it recouped funds in violation of the

parties' collective negotiations agreement and without prior negotiations.

The Board contends that it was entitled to recoup the funds and that the matter is strictly a contractual dispute that does not require negotiating the terms of repayment.

On August 3, 2009, petitioners and the Association filed a joint motion to consolidate and for a determination of predominant interest. On September 17, 2009, the Board also filed a motion to consolidate and for a predominant interest determination. All parties are in agreement that the matters should be consolidated. The Board argues that the Commissioner of Education has the predominant interest. The Association argues that PERC has the predominant interest.

On June 1, 2012, Administrative Law Judge Susan M. Scarola issued an Order For Consolidation and Determination of Predominant Interest finding the matters should be consolidated and that PERC has the predominant interest.

Having independently evaluated the record and considered the Administrative Law Judge's Order, the Chair of the Public

Employment Relations Commission on June 19, 2012, acting pursuant to authority delegated to her by the full Commission and the Commissioner of Education on June 21, 2012, made the following determination in this matter.

#### JOINT ORDER

The matters should be consolidated for hearing before the Administrative Law Judge. The Administrative Law Judge will first offer recommended findings of fact and conclusions of law to both the Public Employment Relations Commission and the Commissioner of Education, disposing of all issues in controversy through a single initial decision under N.J.A.C. 1:1-18.3 and consistent with N.J.A.C. 1:1-17.8(a). Upon transmittal of the initial decision to both agencies, the underlying record will be forwarded to the Public Employment Relations Commission to resolve the unfair practice issues within its jurisdiction.

PERC's decision and the complete record will then be sent to the Commissioner of Education who will then decide any remaining contractual and education law issues.
