PREAMBLE AND RECOGNITION

4 A. **THIS AGREEMENT**, entered into this 9th day of October 2002, by
5 and between the **TOWNSHIP OF SOUTH BRUNSWICK** in the County of Middlesex, a
6 municipal corporation of the State of New Jersey (hereinafter referred to as "the Township"),
7 and **SOUTH BRUNSWICK SUPERIOR OFFICERS ASSOCIATION, FOP LODGE 51**,
8 duly appointed representative of all full time Captains, Lieutenants, Sergeants, and Corporals
9 employed by the Township, excluding all other Patrol Officers, Administrative Captain, and
10 the Chief of Police (hereinafter referred to as "the FOP"), represents the complete and final
11 understanding on all bargained issues between the Township and the FOP.

14 B. The Township hereby recognizes the FOP as the sole and exclusive representative of
15 all employees in the bargaining unit for the purposes of collective negotiations with respect to
16 the negotiable terms and conditions of employment.
