	employment. Any successor agreement so negotiated shall apply to	5
	all employees covered by the recognition clause, be reduced to	6
	writing, and after ratification by the Board and Association,	7
	shall be signed and adopted by both parties.	8
В.	During negotiations, the Board and the Association shall present	9
	data, exchange points of view, and make proposals and counter-	10
	proposals. The Board shall make available to the Association,	11
	upon specific request therefor, any public information concerning	12

E. Year-End Grievances

in the event a grievance is filed at such time that it cannot

be processed through all of the steps in this grievance procedure by

the end of the school year, and, if left unresolved until the beginning

of the following school year could result in irreparable harm to a

party in interest, the time limit set forth herein shall be reduced so

that the grievance procedure may be exhausted prior to the end of the

school year or as soon thereafter as possible.

F. Rights of Employees to Representation

- In Any aggrieved person may be represented at all stages of the grievance procedure by herself, or, at her option, by a representative 14 of her choosing. When an employee is not represented by the Association, 15 the Association through a designated representative, shall have the right 16 to be present and state its views at all levels of the grievance procedure above Level Two.
- 2. No reprisals of any kind shall be taken by either party to this

- B. The Association and its representatives shall have the right to request in writing use of school buildings at all reasonable hours for meetings subject to the approval of the superintendent. The Association shall pay any other out-of-pocket expenses incurred. The Association shall designate one individual who will initiate requests for school facility use and she will be the liaison person between the Association and the School Administration. The Association shall be solely responsible for the restoration of any facility to its original condition upon the conclusion of an Association meeting.
- C. Subject to the prior approval of the Superintendent, the Association shall have the right to use school facilities and equipment, including typewriters, duplicating equipment, calculating machines, and all types of audio-visual equipment outside of regular working hours when such equipment is not otherwise in use. The Association shall pay for the reasonable cost of all materials, services, and supplies incident to such use.

2. Benefits

All benefits to which an employee was entitled at the time 9 of her leave of absence commenced, including unused sick leave, 10 shall be restored to her upon her return, and she shall be 11 assigned to the same position, if available, which she held 12 at the time said leave commenced; or, if not available, to a 13 substantially equivalent position. Pursuant to Section A and B, 14 vacation time shall be pro-rated based on the time worked during 15 the 12-month period. 16
