ADDENDUM TO

MEMORANDUM OF AGREEMENT BETWEEN THE ELIZABETH BOARD OF EDUCATION AND THE

NORTHEAST REGIONAL COUNCIL OF CARPENTERS LOCAL UNION NO. 254, SHEET METAL WORKERS' INT'L ASSOCIATION LOCAL UNION NO. 22, PLUMBERS LOCAL UNION NO. 24, AND THE INTERNATIONAL UNION OF PAINTERS AND ALLIED TRADES AFL-CIO DISTRICT COUNCIL NO. 21, AND THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS LOCAL 102

(2022-2023, 2023-2024, 2024-2025)

This is an Addendum to the Memorandum of Agreement between the Elizabeth Board of Education and the Northeast Regional Council of Carpenters Local Union No. 254, Sheet Metal Workers' Int'l Association Local Union No. 22, Plumbers Local Union No. 24, and the International Union of Painters And Allied Trades AFL-CIO District Council No. 21, and the International Brotherhood of Riectrical Workers Local 102, through their respective representatives which commenced on July 1, 2022 and concludes on June 30, 2025.

The parties agree to modify the Agreement as follows:

I. Article XII Wage Increases

School Year 2022-2023

Salary adjustments of 4% for the 2022-2023 school year.

School Year 2023-2024

Salary adjustments of 3.9% for the 2023-2024 school year.

School Year 2024-2025

Salary adjustments of 3.75% for the 2024-2025 school year.

Article XVI Insurance Benefits/Discounts П.

The parties further agree and acknowledge that effective January 1, 2023 and thereafter the individual member contributions to health care coverage shall be based on Tier 4 of the Chapter 78 tables without discount.

- All other provisions of the Agreement shall remain in full force and effect during the Ш. term of the Agreement.
 - 1. School and District Closings

The parties agree that Union members shall be off duty on days when the schools and District are closed pursuant to the Official Elizabeth Public Schools School Calendar.

2. Overtime Rate

The parties agree that the overtime rate is increased based on the wage rate increases above.

- 3. Reimbursement for Use of Personal Car
 The parties agree that Union members shall receive reimbursement for use of their
 personal automobiles at the NJ OMB mileage rate.
- 4. Article XI Duration of Agreement
 This agreement shall be effective for the period commencing July 1, 2022 and shall
 continue in effect until June 30, 2025.
