THIS AGREEMENT made this 23rd day of December, 1980, BETWEEN:

TOWNSHIP OF UNION IN THE COUNTY OF UNION, a Municipal Corporation of the State of New Jersey, hereinafter referred to as the Township, party of the first part,

AND:

FIRE OFFICERS ASSOCIATION LOCAL NO. 15 OF THE NEW JERSEY STATE ASSOCIATION OF PAID FIRE OFFICERS, hereinafter referred to Association, party of the second part.

WITNESSETH:

WHEREAS, the parties hereto did heretofore under date of July 25, 1979 enter into a certain labor agreement for the members of the Fire Department holding ranks of that above Firefighter other than the Chief; and

WHEREAS, in accordance with said agreement ongoing negotiations have been taking place looking to the conclusion of an agreement for the years 1981 and 1982; and

WHEREAS, the parties hereto have now concluded said negotiations and agreement has been reached;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, the parties hereto do agree that the aforesaid contract of July 25, 1979 be and the same shall be hereby modified and amended in the particulars hereinafter set forth.

ARTICLE II

INCORPORATION OF FMBA AGREEMENT

The parties hereto do agree that all of the terms and provisions of the agreement dated December 23, 1980 between the Township and Local No. 46 of the Firemen's Mutual Benevolent Association of the Township of Union be and the same are hereby adopted as the terms of this agreement between the Township and the Association.

ARTICLE III

COMPENSATION

A. Effective January 1, 1981, the salaries for all employees covered by this agreement shall be as follows:

B. Effective January 1, 1982, the salaries for all employees covered by this agreement shall be as follows:

C. Paragraph C. of said Article is amended for the purpose of increasing the \$300.00 figure therein set forth to . \$500.00.

Paragraph D. of said Article is amended to set forth the percentage increase in each of the categories as hereinafter set forth.

ARTICLE IV

VACATIONS

This Article is amended to include therein the titles Lieutenant and Battalion Chief.

ARTICLE VI

TERM OF AGREEMENT

Paragraph A. of Article VI is amended to read as follows:

This agreement shall be effective as of the first day of January, 1981, and continue in full force and effect until December 31, 1982, or until a new agreement is executed, whichever is later.

Paragraph B. of said Article is amended for the perpose of changing the date of July 1, 1930 to read July1, 1932.

ARTICLE VII

MISCELLANEOUS

Notwithstanding that the titles Lieutenant and Battalion Chief are used in various Articles of this amendatory contract, it is understood and agreed by and between the parties that the use thereof is for descriptive purposes only and that such titles are not to become effective unless and until appointments are made to either or both of said new titles.

All other terms and provisions of said contract of July 25, 1979 not inconsistent herewith are to continue in full force and effect.
