# AMENDMENTS TO THE "AGREEMENT BETWEEN THE DUNELLEN ADMINISTRATORS ASSOCIATION AND THE DUNELLEN BOARD OF EDUCATION

## Article I - Recognition

A. 1. Unit - Amendment:

"The Director of Special Services shall be included in the D.A.A. The Agreement of the D.A.A. and the Board for the 1976-1977 school year shall apply to this individual in its entirety as per the amendments approved on April 12, 1977."

## Article IV - Professional Grievance Procedure

B. 3. Definitions - Amendment:

"and in the case of the Director of Special Services, the immediate supervisor shall be the Superintendent of Schools."

# Article V - Administrator Employment

A. 1. Work Year Contract - Amendment:

"with the exception of the Director of Special Services. The Director of Special Services is employed with a ten month contract on a part-time basis, and is presently working three (3) days per week."

- B. Vacation Vacation Accumulation:
- C. Reimbursement for Unused Vacation:

Sections B and C do not apply to the Director of Special Services.

F. Professional Dues - Amendment:

"Membership for the Director of Special Services shall be paid by the Board of Education for the New Jersey Psychological Association, the American Psychological Association and the New Jersey Association of Pupil Personnel Administrators, provided however, that the Board shall not be obligated to pay in excess of \$150.00 for said membership fees. In addition all fees paid will be pro-rated in accordance with the contracted employment. For this year three-fifths of total fees."

#### Article VIII - Temporary Leaves of Absences

A. Amendment:

"with the exception of the Director of Special Services, who shall receive an amount of the allotments provided within this Article that are in proportion to the work contract being executed between the parties (3/5ths for the 1976-1977 school year).

### Article X - Miscellaneous Provisions

A. Teacher Observation - Amendment:

4. The Director of Special Services shall conduct observations and render evaluations for all members of the Special Services Team, Supplemental Teachers, Special Education Teachers, and at the request of the Building Principal and/or Superintendent of Schools, regular classroom teachers. In the event the Superintendent of Schools requests the Director of Special Services to conduct observations of regular classroom teachers, the Building Principal shall be notified by the Superintendent of this fact in order that the Principal may be aware that said observation and/or evaluation is to take place and in order that the Principal will know that the Director of Special Services will be in the Principal's school building for said purpose.
