SUPPLEMENTARY ITEMS TO THE FORMAL AGREEMENT BETWEEN THE BOARD OF EDUCATION OF MANALAPAN-ENGLISHTOWN REGIONAL SCHOOL DISTRICTS AND THE MANALAPAN-ENGLISHTOWN EDUCATION ASSOCIATION.

A. These supplementary items shall be valid and in addition to those Articles of Agreement only from the 1st day of July 1971 thru June 30, 1972 but shall not be deemed valid and subsisting for any time before the above dates.

ITEM I - ARTICLE XI SALARIES

A. As of September 1, 1971, all full time teachers presently on a half step salary guide will be placed on the next higher step. This increase will be given in addition to the teacher's normal increment; however, this provision shall not be valid for experienced teachers who re-enter teaching after a break in service for any reason during this contract year, nor shall this provision be valid for new teachers entering after September 1st 1971, and serving but a portion of the school year.

TEACHER FACILITIES

A. In schools of this System where there is but one office typewriter, an additional typewriter will be provided by the Board and shall be available for teacher usage when performing tasks necessary to their teaching duties.

ITEM III - ARTICLE XXIII

PROFESSIONAL DEVELOPMENT AND EDUCATIONAL IMPROVEMENT

A. During the second year of the two year Agreement, if the tuition credit cost of New Jersey State Colleges is increased by said institutions, then the Board shall reimburse teachers for completion of courses per the Agreement at a rate that is the average credit-cost for all said schools.

ITEM IV - ARTICLE XXVI

INSURANCE

A. During the 1971-72 school year, the Board shall pay full coverage for continuance in the State Health Benefits Plan for teachers after retirement from the Manalapan-Englishtown Regional School System who elect and are entitled to participation in accordance with the Agreement. This item is not intended to retroactively provide coverage for any teacher presently retired, but shall be available only to those teachers who retire after the effective date of this supplementary agreement.
