INSURANCE PROTECTION

F. Effective July 1, 1981, the Board agrees to provide a Dental Plan for each eligible teacher, and where appropriate, coverage for dependents. AMENDMENT TO AGREEMENT BETWEEN THE BRIGANTINE EDUCATION ASSOCIATION AND THE BOARD OF EDUCATION OF THE CITY OF BRIGANTINE, COUNTY OF ATLANTIC, AND STATE OF NEW JERSEY, DATED MAY 10, 1979.

Pursuant to ARTICLE XXV of the aforesaid Agreement, the Brigantine Education Association and the Board of Education of the City of Brigantine, as a result of negotiations, hereunto amend ARTICLE XX, Section F, and the salary scale referred to in ARTICLE V, Section A, and attach hereto the amended salary scales which shall be effective for the period July 1, 1981, through June 30, 1983.

In addition, all language of the aforesaid Agreement will continue as is, through June 30, 1983.

The aforementioned Agreement and this Amendment shall not be extended orally and it is expressly understood to expire on June 30, 1983.
