MEMORANDUM OF AGREEMENT BETWEEN BOROUGH OF MANASQUAN AND MANASQUAN MUNICIPAL EMPLOYEES' ASSOCIATION

This Memorandum of Agreement is made on this 28% day of INSTITUTE OF MANAGEMENT August, 1989, between the:

BOROUGH OF MANASQUAN (from now on called "Manasquan")

and

RUTGERS UNIVERSITY MANASQUAN MUNICIPAL EMPLOYEES' ASSOCIATION (from now on called the "Association")

- 1. Manasquan and the Association entered into an Employment Agreement for the employment years 1986, 1987 and 1988 (from now on called the "Prior Employment Agreement"). The parties have successfully negotiated a new employment agreement with an effective commencement date of January 1, 1989 through June 30, 1990. All of the terms and conditions of the Prior Employment Agreement shall remain in full force and effect except as modified in this Memorardum of Agreement as modified in this Memorandum of Agreement.
- 2. The members of the Association shall receive a zero increase in salary for the period commencing January 1, 1989 to June 30, 1989.
- 3. From July 1, 1989 through December 31, 1989, following shall apply:
- A. All persons classified as laborers in the Association shall continue to be paid a salary equal to the highest salary paid to such person during the 1988 calendar year.
- B. The increase over the 1988 base annual salary of Association members designated as Mechanic, Water/Sewer, Heavy Equipment Operator, Recycling, Park Maintenance, Equipment Operator/Sweeper, Equipment Operator and Water Meter Supervisor shall be as follows:

Mechanic - Mr. De Vos	\$1,793.00
Water/Sewer - Mr. Martinson	\$1,793.00
Heavy Equipment Operator - Mr. Layton	\$1,793.00
Recycling - Mr. Cowdrick	\$1,793.00
Park Maintenance - Mr. Nicasto	\$1,793.00
Equipment Operator/Sweeper - Mr. Hasfield	\$1,793.00
Equipment OperatorMr. Blair	\$ 896.00
Water Meter Supervisor - Mr. Keynton	\$ 896.00

- 4. For the period from January 1, 1990 to June 30, 1990, all members of the Association shall receive a five (5%) percent increase in their base salary. Notwithstanding this provision, the Association shall have the right to reopen salary negotiations for the period covering January 1, 1990 to June 30, 1990. The Association shall have the right to require Manasquan to commence negotiations on and after October 1, 1989.
 - 5. The medical benefits of the members of the Association shall be expanded to include a prescription drug plan selected by Manasquan.
 - 6. Manasquan represents to the Association that execution of this agreement has been approved by the Borough Council.
 - 7. The Association represents to Manasquan that execution of this agreement has been approved by a majority vote of the members of the Association.
