

AGREEMENT

Between The Board of Education Mainland Regional High School District

and

The Mainland Regional Secretaries! Association for the Period July 1, 1975 - June 30, 1977

<u>Preamble</u>

This Agreement is made and entered into on this 14th day of July 1975, by and between The Mainland Regional High School District Board of Education, hereinafter called the "Board", and the Mainland Regional Secretaries' Association, hereinafter called the "Association".

ARTICLE II

Negotiations Procedure

Α.	The parties agree to enter into collective negotiations over an	1
	agreement in accordance with the New Jersey Employees Relations	2
	Act, Public Laws of New Jersey, in a good faith effort to reach	3
	agreement on all matters concerning the terms and conditions of	4
	employment. Any successor agreement so negotiated shall apply to	5
	all employees covered by the recognition clause, be reduced to	6
	writing, and after ratification by the Board and Association,	7
	shall be signed and adopted by both parties.	8
В.	During negotiations, the Board and the Association shall present	1
	data, exchange points of view, and make proposals and counter-	2
	proposals. The Board shall make available to the Association,	3
	upon specific request therefor, any public information concerning	.4
	negotiations.	5
С.	Neither party in any negotiations shall have control over the	1
	selection of the negotiating representatives of the other party.	2
	The parties mutually pledge that their representatives shall be	3
	clothed with the necessary power and authority to make proposals,	4

D.	All meetings between the parties shall be regularly scheduled	1

ARTICLE II - Negotiations Procedure (cont'd)

- E. This Agreement incorporates the entire understanding of the parties on all matters which are or could have been the subject of negotiations during the term of this agreement. Neither party shall be required to negotiate with respect to any such matter whether or not covered by this agreement, and whether or not within the knowledge or contemplation of either or both parties at the time they negotiated or executed this agreement.
- F. This agreement shall not be modified in whole or in part; by the parties except by an instrument in writing duly executed by both parties.

ARTICLE III - Grievance Procedure (cont'd)

d. In matters where the Board is without authority to act.

C. Steps of the Grievance Procedure

The following constitutes the sole and exclusive method for dissolving grievances between the parties covered by this agreement and shall be followed in its entirety unless any step is waived by mutual consent:

1. <u>Level One - Informal Resolution</u>

An aggrieved employee shall institute action under the provisions hereof within ten (10) days of the occurrence or after becoming aware of a potentially grievable situation during the summer months by discussing it with her immediate superior or principal, with the objective of resolving the matter informally. Failure to act within said ten (10) days shall be deemed to constitute an abandonment of the grievance.

2. Level Two - Immediate Superior

If the aggrieved individual is not satisfied with the disposition of her grievance at Level One or if no decision has been rendered within five (5) school days after the presentation of the grievance, she shall then discuss it with her school principal with the objective of resolving the matter informally. The employee shall indicate to the building principal that a grievance hearing is taking place.

ARTICLE III - Grievance Procedure (cont'd)

Steps of the Grievance Procedure (cont'd) С.

3. Level Three - Superintendent

If the aggrieved individual is not satisfied with the dis-1 position of her grievance at Level Two, or if no decision has 2 been rendered within five (5) school days after the presentation 3 of the grievance, she may submit the grievance in writing within 4 five (5) school days after the decision at Level Two or ten (10) school days after the grievance was presented at Level Two, whichever is earlier, to the Superintendent of Schools. 7

4. Level Four - Board of Education

If the aggrieved individual is not satisfied with the dis-1 position of her grievance at Level Three, or if no decision has 2 been rendered within ten (10) school days after the grievance was delivered to the Superintendent, she may within five (5) school 4 days after a decision by the Superintendent or fifteen (15) school days after the grievance was delivered to the Superintendent, 6 whichever is sooner, request in writing that her grievance be submitted for review by the Board of Education. The Board shall 8 review the case and may hold a hearing with the employee, if re-9 quested by the employee. An administrator may be present at this 10 level. 11

The Board shall render a decision in writing within twenty-one (21) school days of receipt of the grievance. Copies of the decision of the Board of Education shall be sent to the aggrieved, to the Superintendent, and to the principal and President of the Association.

C. Steps of the Grievance Procedure (cont'd)

5. Level Five - Arbitration

- If the aggrieved person is not satisfied with the disa. 1 position of his grievance at Level Four, or if no decision has been rendered within twenty-two (22) school days after the grievance was delivered to the Board, she may within five (5) school days after a decision by the Board, or twenty-two (22) school days after the grievance was delivered to the Board, whichever is sooner, request in writing that her grievance be submitted to arbitration. 8 Within ten (10) school days after such written notice of submission to arbitration, both parties shall attempt to agree upon a mutually acceptable arbitrator and shall attempt to obtain a commitment from said arbitrator to serve. If the
 - parties are unable to agree upon an arbitrator, or to obtain such a commitment within the specified time period, a request for a list of arbitrators may be made to the American Arbitration Association by either party. The parties shall then be bound by the rules and procedures of the American Arbitration Association concerning the selection of an arbitrator. 10
- The arbitrator so selected shall hold hearings promptly 1 C. and shall issue his decision no later than twenty (20) school 2 days from the date of the close of the hearings, or if oral 3 hearings have been waived, from the date the final statements 4 and proofs on the issues are submitted to him. The arbitrator 5 shall be bound by the provisions of this agreement and 6

ARTICLE III - Grievance Procedure (cont'd)

C. Steps of the Grievance Procedure (cont'd)

5. Level Five - Arbitration (cont'd)

- c. (cont'd) restricted to the application of the facts pre-1 sented to him involving the grievance. The arbitrator shall not have the authority to add to, modify, detract 3 from, or alter in any way the provisions of this agreement or any amendment or supplement thereto. The arbitrator's 5 decision shall be in writing and shall set forth his findings 6 of fact, reasoning, and conclusions on the issues submitted; 7 the arbitrator shall be without authority or power to make 8 any decision which requires the commission of an act pro-9 hibited by law or which is violative of the terms of this 10 agreement. The arbitrator's decision shall be submitted to 11 the Board and the Association and shall be binding on both 12 13 parties.
 - d. The costs for the services of the arbitrator shall be

 borne equally between the Board of Education and the Asso
 ciation; any other expenses, including but not limited to

 the presentation of witnesses, room rental, or any other

 matter, shall be paid by the party incurring same.

D. <u>Time Limits</u>

Since it is important that grievances be processed as rapidly as

possible, the number of days indicated at each Level should be con
sidered as a maximum and every effort should be made to expediate

the process. The time limit specified may, however, be extended by

mutual agreement. Failure in any step of this procedure to communicate

D. Time Limits (cont'd)

the decision on the grievance within the specified time limits shall permit the grievant to proceed to the next step. Failure in any step of this procedure to appeal a grievance at the next step within the specified time limits shall be deemed to be a waiver of further appeal of the decision rendered.

E. Year-End Grievances

In the event a grievance is filed at such time that it cannot be processed through all of the steps in this grievance procedure by the end of the school year, and, if left unresolved until the beginning of the following school year could result in irreparable harm to a party in interest, the time limit set forth herein shall be reduced so that the grievance procedure may be exhausted prior to the end of the school year or as soon thereafter as possible.

F. Rights of Employees to Representation

- 1. Any aggrieved person may be represented at all stages of the grievance procedure by herself, or, at her option, by a representative of her choosing. When an employee is not represented by the Association, the Association through a designated representative, shall have the right to be present and state its views at all levels of the grievance procedure above Level Two.
- 2. No reprisals of any kind shall be taken by either party to this agreement against any employee whether or not a member of the bargain—ing unit or the Association who shall participate in the grievance procedure by reason of such participation.

ARTICLE III - Grievance Procedure (cont'd)

G. Miscellaneous

1. If a grievance affects a group of employees, by mutual
agreement of the parties, such grievance may be consolidated, and
where appropriate, may be instituted at Level Two of the grievance
procedure.

- 2. Forms for filing grievances, serving notices, taking appeals, making reports and recommendations and other necessary documents shall be prepared jointly by the Superintendent and the Association subject to Board approval and shall be given appropriate distribution so as to facilitate operation of the grievance procedure.
- 3. All meetings and hearings under this procedure shall not be conducted in public and shall include only such parties and their designated or selected representatives as heretofore referred to in this Article.
- 4. All documents, communications, and records dealing with the processing of a grievance shall be filed in a separate grievance file and shall not be kept in the personnel file of any of the participants.

ARTICLE V

Association Rights and Privileges

Α.	The Board hereby agrees to furnish to the Association in response
	to reasonable requests therefor, relevant information which is in
	the public domaine, concerning negotiations and pending grievances.

- B. The Association and its representatives shall have the right to request in writing use of school buildings at all reasonable hours for meetings subject to the approval of the Superintendent. The Association shall pay any other out-of-pocket expenses incurred. The Association shall designate one individual who will initiate requests for school facility use and she will be the liaison person between the Association and the School Administration. The Association shall be solely responsible for the restoration of any facility to its original condition upon the conclusion of an Association meeting.
- C. Subject to the prior approval of the Superintendent, the Association shall have the right to use school facilities and equipment, including typewriters, mimeographing machines, other duplicating equipment, calculating machines, and all types of audio-visual equipment at reasonable times, when such equipment is not otherwise in use. The Association shall pay for the reasonable cost of all materials, services, and supplies incident to such use.

ARTICLE XI - Extended Leave of Absence (cont'd)

F. Return from Leave

Salary

Upon return from leave granted pursuant to Section A or B 1 of this article, an employee shall not be considered as if she 2 were actively employed by the Board during the leave and shall not be placed on the salary schedule at the level she would have achieved if she had not been absent. If an employee is absent pursuant to Sections A and B more than one-half year, 6 she shall not receive the increment. If she is absent a half 7 year or less, she shall receive her salary increment. 8

Benefits

All benefits to which an employee was entitled at the time 1 of her leave of absence commenced, including unused sick leave, 2 shall be restored to her upon her return, and she shall be 3 assigned to the same position, if available, which she held at the time said leave commenced; or, if not available, to a substantially equivalent position. Pursuant to Section A and B, vacation time shall be pro-rated based on the time worked during 7 the 12-month period. 8
