(An addendum to be attached to the current Agreement
which covers the period of July 1, 1982 to June 30, 1985.)

Subject to ratification by the Board and the Association, the negotiation committees of the parties agree that the current 1982 to 1985 Agreement concerning terms and conditions of employment of all certified personnel shall remain in effect through June 30, 1987 with the following additions:

The attached Salary Guides with these notes:

- A. In 1984-85 Step 1 will encompass those staff members presently on Steps 1 and 2. Likewise, Step 4 will take in those presently on 5 and 6, and Step 14 those presently on 16 and 17.
- B. In succeeding years, 1985-86 and 1986-87, staff members will remain on their 1984-85 Step.
- C. All staff presently on Step 19 through 23 will receive the following remuneration:
 1. 1984-85: an 8.7% increase based upon present salary
 2. 1985-86: a 7.7% increase based upon 1984-85 salary
 3. 1986-87: a 7.5% increase based upon 1985-86 salary
- D. The super max salaries shall be established by adding a fixed dollar amount to the preceding year's super max figure. This fixed dollar amount shall increase from Column A to Column H. This will be the procedure used to determine the super max salary figures in each year of the Agreement. The 25-year super max figure will

increase an additional \$1000 each year of this Agreement over the established super max salary in Column A. (applicable only to the present incumbent)

E. Department Chairmen's stipends shall be \$1800 annually during the term of this Agreement (1984-1987).

F. Tuition for 1985-86 will be increased to \$425 and in 1986-87 it will be \$450.

G. Retirement Package: During the years 1985-86 and 1986-87 only, the board agrees to pay \$10,000 to any person retiring from the profession. Payment shall be made in one of the following ways:

1. one lump sum at retirement;
2. For those retiring in December the payment shall be made in the following calendar year;
3. An arrangement which is mutually acceptable to the retiree and the board secretary.
