
RESOLUTION AUTHORIZING THE EXECUTION OF A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE TOWNSHIP OF MONTVILLE AND MORRIS COUNCIL NO. 6, NJCSA, IFPTE, AFL-CIO (WHITE COLLAR UNIT) JANUARY 1, 2016 THROUGH DECEMBER 31, 2016

WHEREAS, the Township of Montville and Morris Council No. 6, NJCSA, IFPTE, AFL-CIO have engaged in collective bargaining pursuant to N.J.S.A. 34:13A-1 et. seq.; and

WHEREAS, the Township of Montville desires to enter into a Collective Bargaining Agreement with the Morris Council No. 6, NJCSA, IFPTE, AFL-CIO (White Collar Unit) for 2016 (January 1, 2016 through December 31, 2016);

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Montville, County of Morris and State of New Jersey, that the Township Administrator be and is hereby authorized to sign the Collective Bargaining Agreement with Morris Council No. 6, NJCSA, IFPTE, AFL-CIO (White Collar Unit) that is hereto attached.

EXTENSION OF COLLECTIVE NEGOTIATIONS AGREEMENT

This Addendum to the January 1, 2013 through December 31, 2015 Collective Negotiations Agreement ("Agreement") is entered into on this 5 day of ^{JAN 2016}~~December, 2015~~ by and between the Township of Montville ("Township") and Morris Council No. 6, NJCSA, IFPTE, AFL-CIO (White Collar Unit)(hereinafter "Morris Council No. 6").

The parties agree as follows:

1. Duration: January 1, 2016 through December 31, 2016.
2. The parties have agreed to extend the terms and conditions of the existing Agreement between the parties for the duration of the time set forth in Paragraph 1 above, except as modified herein.
3. Any terms and conditions not contained herein shall remain in full force and effect until a successor agreement has been negotiated.
4. Salary
 - a. Effective January 1, 2016 there shall be a two percent (2%) increase to each step on the Salary Guide.
 - b. Effective January 1, 2016, all eligible employees shall move one step on the Salary Guide.
5. This Addendum shall be subject to ratification by the membership of Morris Council No. 6 and approval of the Township Committee.

IN WITNESS WHEREOF, the parties hereto have duly executed this Agreement as of the date indicated above.
