DURATION


This Agreement entered into this 20th day of December , 2000 shall be effective from January 1, 2001 through December 31, 2001. Any changes in salary or other economic benefits will apply only to those police officers in the employ of the City as of the date of signing of this Agreement or who retired from the employ of the City or who died during the term of this Agreement. Either party wishing to terminate, amend, or modify this Agreement after December 31, 2001 must do so by giving written notice to the other party, no more than 120 days and no less than 60 days prior to December 31, 2001.

In the event that a notification pursuant to above has been given by either Party as required above and a new contract has not been entered into by January 1, 2002, it is agreed and understood that this Agreement shall remain in full force and effect until such new contract is ratified by both parties.


