NOW, THEREFORE, be it resolved by the Mayor and Council of the Township of Greenwich, County of Gloucester, State of New Jersey to approve the Memorandum Extending Agreement attached as Exhibit A between the Township of Greenwich and Teamsters Local 676 for the time period January 1, 2017 through December 31, 2017.

BE IT FURTHER RESOLVED to authorize the Mayor and Municipal Clerk to sign the agreement (Schedule A) on behalf of the Township of Greenwich.

Memorandum Extending Agreement between Township of Greenwich and Teamsters Local 676

The Township of Greenwich and Teamsters Local 676 are parties to a collective negotiation agreement ("Agreement") with an expiration date of December 31, 2016.

The parties agree to extend the Agreement for an additional year through December 31, 2017, subject to the following changes:

- 1. Article XV (Uniforms) is amended by adding the following:
- G. In lieu of a uniform cleaning service, employees will receive an annual uniform cleaning allowance of \$650. Payment will be made in the first pay in December of each year. The payment for 2017 will be prorated at \$325.
 - 2. Article 17 (Salaries) is amended as follows:
- A. The base salary of all employees for 2017 shall be increased by two percent (2%) from 2016. The increase is retroactive to January 1, 2017.

Except as modified above, all other terms and conditions of the Agreement remain unchanged and continue in effect.
