AGREEMENT  
Dated: September 2, 1975

WHEREAS, pursuant to Chapter 303, of the Laws of 1968, as amended, the Fort Lee Board of Education and the Fort Lee Coalition of Teachers have heretofore entered into an Agreement dated September 9, 1974, covering terms and conditions of employment for the period September 1, 1974 through June 30, 1976, and

WHEREAS, said Agreement, dated September 9, 1974, provided in Article XXVII that either party should have the right to reopen the Agreement for negotiations on salary schedules A, B and C for the 1975-76 school year, and

WHEREAS, the parties met and conferred regarding salary schedules for the 1975-76 school year, and

WHEREAS as a result of said meetings the negotiating teams representing the respective parties did enter into a Memorandum of Understanding dated June 10, 1975, which Memorandum of Understanding was subsequently ratified by the parties hereto, and

WHEREAS, pursuant to said Memorandum of Understanding the parties have met and conferred regarding the salary schedules for the 1975-76 school year and have mutually prepared the salary schedules as herein set forth.

NOW, THEREFORE, IT IS AGREED between the Fort Lee Board of Education and the Fort Lee Coalition of Teachers as follows:

1. Salaries for the 1975-76 school year for those employees in the categories listed under Article I, paragraph A of the Agreement dated September 9, 1974, shall be fixed and determined pursuant to the terms of the salary guide set forth in exhibit C-1, schedule A, which is attached hereto and made part hereof. Exhibits D, E and F of schedule A of the Agreement dated September 9, 1974 shall remain the same for the 1975-76 school year.
2. The Bonus Guide for Co-curricular activities for the 1975-76 school year, shall be fixed and determined pursuant to the terms of schedule B.B., which is attached hereto and made part hereof.
3. The parties agree to have a subcommittee consisting of representa-

tives of each negotiating team meet as soon as possible, but in no event more than thirty (30) days from the date of this Agreement, for purposes of negotiating adjustments to the Bonus Guide for Interscholastic Athletic Personnel of the Fort Lee Public School System, Schedule C., of the Agreement dated September 9, 1974. Pending an agreement on adjustments to the said schedule C., personnel employed as athletic coaches shall be compensated on the basis of the existing salary guide for such coaching assignments.

4. All the other provisions, terms and conditions of the Agreement dated September 9, 1974, between the parties hereto for the period September 1, 1974 through June 30, 1976, shall remain in full force and effect.
