### Collective Bargaining Procedure

- A. Collective bargaining; with respect to rates of pay, hours of work or other conditions of employment, shall be conducted by a duly-authorized bargaining agent of each of the parties to this Agreement.
- B. Collective bargaining meetings shall be held at times and places mutually convenient at the request of either party.
- C. Employees of the Employer, not to exceed two (2) in number, who may be designated by the PBA to participate at collective bargaining meetings called for the purpose of the negotiation of collective bargaining will be excused from their work assignments to attend such collective bargaining meetings.

#### ARTICLE III

#### Discrimination and Coercion

A. There shall be no discrimination, interference or coercion by the Employer or any of its agents against the employees represented by the PBA because of membership or activity in the PBA. The PBA shall not intimidate or coerce employees into membership. Neither the Employer nor the PBA shall discriminate against any employees because of race, color, creed, sex, national

No material derogatory to employee's conduct, service, character or personality shall be placed in his or her personnel file unless the employee has had an opportunity to review the material by affixing his or her initials to the document to be filed with the express understanding that such initials in no way indicate agreement with the contents thereof. The employee shall also have the right to submit a written reply (example: rebuttal, answer, etc.) to such material and this reply shall be reviewed by the Chief of Police and a Township designee at the employee's request. #### <u> Sick Leave</u>

- A. All permanent full-time employees covered by this Agreement shall be granted sick leave with pay pursuant to the following schedule.
  - 1. The first calendar year that an employee is employed in a full-time capacity, sick time shall be earned at the rate of one quarter (1.25) days for each calendar month that the employee is employed. Thereafter, beginning on the first day of January, each employee shall be entitled to fifteen (15) days for each and every calendar year thereafter. The amount of sick leave not taken shall accumulate from year to year.
    - 2. The employer reserves the right to extend sick time.
  - 3. Up to five (5) days of an employee's personal sick leave may be used each year to attend the illness of immediate family members, which shall include the following individuals: mother, father, spouse, son and daughter.
  - B. One (1) sick leave day shall equal eight (8) hours. Sick leave for less than a full day (eight hours) shall be utilized on an hourly basis, in which event only the hours used as sick time shall be deducted from the employee's accumulated sick time.
  - C. No employee shall make doctor visits while on duty. Sick time may be utilized for such visits.

- E. 1. When an officer retires from the Police Department in accordance with the appropriate New Jersey Pension Plan, he/she shall have his/her accumulated sick time purchased at the then current rate of pay to a maximum cap of \$15,000.
  - 2. In order to receive payment for accumulated sick time during the year of actual retirement, an employee shall notify the Township, in writing, during the preceding calendar year of the intention to retire.

An employee who dies in the line of duty shall be eligible for the benefits in E.1. above with the payment to the Officer's estate in the next calendar year.

## Bereavement Leave:

- 1. Employees shall receive five (5) working days off with pay (commencing on the day of death) for the following individuals: father, mother, grandparent, spouse, son, daughter, brother, sister, father-in-law, mother-in-law, son-in-law, daughter-in-law, grandchild, spouse's grandparents.
- 2. The employee shall receive one (1) day off with pay (day of burial and only if funeral services are attended) for the following: uncle, aunt, nephew, niece, brother and sister-in-law, or cousin of the first degree.
- 3. Exceptions to benefits set forth in paragraphs one (1) and two (2) above may be made by the Chief of Police or the Township Administrator when the deceased is buried in another city and the employee would be unable to return in time for duty with the leave granted in this section.

- 2. Compensatory time must be used within one hundred fifty (150) days of the date it is earned unless it cannot be scheduled by the department in which case the time shall be extended for an additional thirty (30) days.
- G. All employees shall be eligible for all overtime. The Chief of Police, or his designee, shall maintain an overtime list consisting of the names of all employees. Overtime shall be offered to employees on the list on a rotation basis. The overtime list shall be posted in a conspicuous place and/or available for employee inspection. All employees shall, however, receive an annual one hundred eighty dollars (\$180.00) added to their base salaries. In 1992, the one hundred eighty dollars shall be applied to base salaries after the computation of the January 1, 1992, 6.5% increase.
- 2. All employees shall have the option of continuing their life insurance coverage at the employee's own expense. Any employee exercising this option shall notify the employer, in writing, on or before December 1 of each calendar year.
- 3. Employees electing to continue their life insurance coverage shall, nonetheless, be entitled to the annual one hundred eighty dollars (\$180.00).
- 4. Employer and PBA recognize that three officers' life insurance premiums are substantially higher than other officers'. In recognition of the special circumstances peculiar to these three officers, the Employer and PBA therefore have entered into a separate agreement concerning these three officers.

#### MEMORANDUM OF AGREEMENT

WHEREAS, the TOWNSHIP OF STAFFORD (herein "Township") is a corporate body politic, in the County of Ocean, State of New Jersey and the STAFFORD TOWNSHIP POLICEMEN'S BENEVOLENT ASSOCIATION, LOCAL 297 (herein "The PBA"), is the bargaining agent on behalf of members of the Stafford Township Police Department, Township of Stafford, County of Ocean, State of New Jersey.

WHEREAS, the Township and the PBA entered into a Collective Bargaining Agreement setting forth the terms and conditions of employment on or about November 14, 1991.

WHEREAS, pursuant to Article XI (G) of the Collective Bargaining Agreement, all PBA members are eligible for overtime, and pursuant thereto, the Chief of Police (or his designee) is required to maintain an overtime list consisting of the names of all employees, and the Chief is further required to offer overtime to PBA members on the list on a rotation basis.

WHEREAS, a dispute arose by and between the Township and the PBA concerning Article XI (G), and a grievance was filed by the PBA, concerning same on or about November 22, 1991.

WHEREAS, the Township and the PBA have reached an agreement which is mutually agreeable to both parties and are desirous of reducing that agreement to writing and enter into this Memorandum to clarify the meaning and provisions of Article XI (G) of the aforesaid Collective Bargaining Agreement.

NOW, THEREFORE, with the express purpose of resolving the

aforesaid dispute, and in consideration thereof, the provisions of Article XI (G) of the Collective Bargaining Agreement by and between the parties, dated November 14, 1991, shall be governed and superseded by the following:

- 1. Overtime which involves more than four hours shall be offered in accordance with the overtime rotation list. Hence, for instance, overtime which consists either of four (4) hours or eight (8) hours shall be referred to the overtime rotation list.
- 2. Both the PBA and the Township recognize that the rotation list should not be utilized when overtime consists of specialized work. Such specialized work includes, but is not limited to, DWI assignments, Identification assignments, photography assignments, crime prevention assignments, and traffic safety assignments (i.e., investigation of fatal accidents).

It is acknowledged that the above examples of "specialized" assignments is not exclusive, and it is specifically agreed by and between the PBA and the Township that such "specialized" overtime shall not be referred to the aforesaid overtime rotation list.

3. It is understood by and between the parties that, in certain instances, police officers will be required to work beyond their normal shift in response to specific emergency situations or to complete an assigned task. For instance, the occasion may arise where a police officer responds to an accident and attends to same beyond his/her normal shift. In that instance, the Township shall not be obligated to refer to the rotation list and, therefore, will

not be required to offer overtime to another PBA member to complete the response to said accident.

- 4. It is further agreed and understood that in the event there are further disagreements as to the specific types of overtime which shall be referred to the rotation list, that both parties shall use their best efforts to cooperate and resolve the problem.
- 5. It is further agreed and understood between the Township and the PBA that the terms and conditions of this agreement shall supersede and control over any provisions to the contrary which are set forth in Article XI (G) in the aforesaid Collective Bargaining Agreement.

IN WITNESS WHEREOF, the undersigned have affixed their signatures as the duly authorized legal representatives of the Township and the PBA and by signing below specifically agree to the terms and provisions set forth in this Addendum.
