AGREEMENT

THIS AGREEMENT, made and entered into this 2 day of 2021 by and between the BOARD OF COMMISSIONERS OF THE CITY OF BORDENTOWN, NEW JERSEY, hereinafter referred to as the "City", and the BORDENTOWN CITY PUBLIC SAFETY EMPLOYEES, hereinafter referred to as the "Safety or Employee" has as its purpose the improvement and promotion of harmonious employee relations between the City and its employees, the establishment of equitable and peaceful procedures for the amicable resolution of all disputes and grievances and the determination of the wages, hours of work and other terms and conditions of employment.

ARTICLE I

VACATION LEAVE

- **A.** Employees covered by this Agreement and eligible for vacation leave with pay shall be entitled to vacation leave as follows:
- 1. One (1) working day of vacation for each month of employment during the first calendar year of employment.

One (1) to Five (5) Years of Service
 Five (5) to Twelve (12) Years of Service
 Twelve (12) to Twenty (20) Years of Service
 Over Twenty (20) Years of Service
 Thirteen (13) Days = 104 hours
 Sixteen (16) Days = 128 hours
 Twenty-one (21) Days = 168 hours
 Twenty-six (26) Days = 208 hours

- **B.** Vacation leave is credited in advance at the beginning of the calendar year in <u>anticipation of</u> <u>Continued employment</u> for the full year in accordance with Article I, Paragraph A, Sections 1 thru 5.
- C. When the number of vacation days to which an employee entitled in accordance with Article I, Paragraph A changes; the change shall occur as of the employee's anniversary date. Vacation time will accrue based on the employee's date of hire and any new employee, following their successful probationary period, shall be credited with vacation time from the date of hire. The number of additional days granted in the anniversary year shall be prorated for the remainder of the calendar year.
- **D.** Vacation leave for a given calendar year may be carried forward into the succeeding year but must be taken prior to June 30th of the succeeding calendar year as permitted or directed by the City Clerk or his/her designee. If it is determined that it cannot be taken because of pressure of work, vacation time may be carried beyond June 30th of the succeeding calendar year if so granted by the City Clerk, his/her designee and or the Board of Commissioners.
- **E.** Employees covered under this Agreement shall have the option to sell back up to 80 hours of unused vacation leave carried over from the prior year. The request to sell back must be in writing to the Board of Commissioners on or before June 30th of the succeeding year.
- **F.** In the event an employee covered under this Agreement is entitled to vacation leave at the time of the employee's death, that employee's surviving spouse or estate shall receive compensation for earned vacation leave for the current year prorated upon the

number of months worked in the calendar year in which the death occurred plus any vacation leave which may have been carried over from the preceding calendar year.

G. Upon separation from the City through resignation or upon retirement, employees covered under this Agreement shall be entitled to vacation leave for the current year prorated upon the number of months worked in the calendar year in which the separation or retirement becomes effective plus any vacation leave which may have been carried over from the preceding calendar year

ARTICLE II

HOLIDAYS

A. The following shall be designated paid Holidays:

New Year's Day Martin Luther King's Birthday

Washington's Birthday (Presidents Day) Good Friday

Memorial Day Juneteenth (June 19th)

Independence Day
General Election Day
Thanksgiving Day

Labor Day
Veteran's Day
Christmas Day

B. The day following New Year's, Thanksgiving, and Christmas Day, whenever such following day is a normal weekly workday shall be included as a paid Holiday.

C. Employees will be entitled to two (2) floating Holidays (Lincoln's Birthday, Columbus Day) to be used at the employee's discretion and at the approval of the Chief of Police according to manpower and work demand.

- **D.** When a Holiday falls on a Saturday, employees shall receive the preceding Friday off. Should the Holiday fall on a Sunday, the employee shall receive the following Monday off.
- **E.** Employees hired prior to June 2012 shall receive Holiday Pay once per year payable to the employee on or before December 7th of the calendar year. If an employee is terminated, resigns or retires, he/she shall be entitled to payment of Holiday pay for those Holidays which have occurred prior to termination, resignation or retirement.

ARTICLE III

WORK HOURS AND OVERTIME

For the purpose of this agreement, scheduled, non-emergency overtime shall be defined as any work hours in excess of eight (8) hours per day or forty (40) hours per week shall be deemed overtime. Overtime shall be compensated at the rate of $1\frac{1}{2}$ times the employee's regular hourly rate as determined by the base salary calculation.

When non-scheduled overtime has occurred the officer that is required or requested to respond shall be paid for a minimum of two (2) Hours.

ARTICLE IV

OUTSIDE EMPLOYMENT

- **A.** All outside employment for Special Events shall be designated and assigned by the Chief of Police or his/her designee.
- **B.** A Special Event shall be defined as an event held within the City of Bordentown and attendance at same is required by the Chief of Police or his/her designee.
- C. Compensation for Special Events will be at the discretion of the Chief of Police or his/her designee with regard to employee's regular overtime rate, minimum call in as described in Article III or outside employment rate as specified in the Bordentown City Police Officers' Association Agreement.

ARTICLE V

SICK LEAVE

Employees covered under this Agreement shall be entitled to the use of paid sick leave provided herein:

A. Sick leave may be utilized by employees when they are unable to perform their work by reason of personal illness, accident or exposure to contagious disease. Sick leave may also be used for short periods because of death in an employee's immediate family or for the attendance of the employee upon a member of the immediate family who is seriously ill.

"Immediate family for purpose of this Article shall include Spouse, Child, Mother, Father, Step-Parent, Step-Child, Mother-in-Law, Father-in-Law, Son-in-Law, Daughter-in-Law, Grandparent, Grandchild, Sibling or member of the employee's household"

- **B.** Sick leave entitlement shall be as follows:
 - 1. All eligible employees covered by this Agreement will receive fifteen (15) days (120 hours) of paid sick leave each year.
 - 2. During the first year of employment, a new employee shall accrue sick leave beginning with the employee's first full day as a full-time employee and proceeding through the remainder of the first calendar year on a pro-rated monthly basis. Paid sick leave will be made available following the successful completion of the probationary period.
 - 3. In each full calendar year thereafter, an employee shall be entitled to fifteen (15) days (120 hours) sick leave. The leave is credited in advance on January 1 in <u>anticipation of continued employment</u> for the full year and may be used on the basis and in accordance with established City policy. Such leave not utilized shall be accumulated.
 - 4. If an employee resigns or otherwise leaves his/her position with the City, the City has the right to prorate an employee's sick time upon separation of service, and the employee will be

entitled to utilize a prorated amount of their sick leave in the year of their separation of service.

- 5. If an employee resigns his/her position with the City, the employee shall forfeit all accumulated/earned sick leave
- 6. Upon retirement, those employees hired prior to May 21, 2010 shall be entitled to payment of fifty percent (50%) of all unused sick leave which they have accumulated at the time of retirement, up to a maximum benefit payable up to \$18,000.00.
- 7. Upon retirement, those employees hired on or after May 21, 2010 shall be entitled to payment of fifty (50%) of all unused sick leave which they have accumulated at the time of retirement, up to a maximum benefit payable up to \$15,000 in accordance with Chapter 3 PL 2010.
- 8. When planning retirement, the employee must notify the City of his/her plan to retire the year before the employee's expected retirement date for budget purposes. If the employee notifies the City his/her intent to retire the year before retirement, the employee shall receive his/her accumulated sick leave three (3) weeks following the adoption of the City's budget. If an employee fails to provide notice of retirement the year before the employee retires, the employee shall **not** receive payment of unused accumulated sick leave until the year following retirement unless it is determined by the Chief Finance Officer that funds are available in the municipal budget of the City.
- 9. For purposes of this Agreement, retirement shall be pursuant to the provisions of a State administered or approved retirement system.
- 10. Upon the death of an employee, regardless of the date of hire, payment of accumulated sick leave and any prorated sick leave for the year in which the death occurs shall be paid by the City to the spouse or estate of the employee. Payment for sick leave shall be in an amount equal to fifty (50%) of all unused sick leave which they have accumulated at the time of death, up to a maximum as defined in Article V, Paragraph 6 and 7 of said agreement.

C. Notification of the use of sick leave shall be as follows:

- 1. In all cases of illness, whether of short duration or long term, the employee is required to notify his/her superior that he/she will be out of work, giving the expected date of return to work if same can be provided. Notification of use of a sick day is to be given at the earliest possible time but in no event less than the employee's usual reporting time, or other time as occasioned or necessitated by the circumstances.
- 2. If the duration of absence exceeds two (2) days, it will be necessary to report on every third day. Failure to report absences or abuse of sick leave privileges on the part of any employee may be cause for disciplinary action and/or dismissal.
- 3. When it is known beforehand that sick leave will be required for more than ten (10) days, such leave must be requested by the employee in writing to his/her immediate supervisor. This request

must be accompanied by a written and signed note from a treating physician prescribing that sick leave is necessary and must, if possible, include the anticipated duration of the leave

- 4. Employees will not be charged for sick leave on non-work days, inclusive of holidays, for all City employees.
- 5. A physician's note may be requested by the Chief of Police from an employee on sick leave, whenever such requirement appears reasonable.
- **D.** When an employee is on vacation and requires sick leave for any portion of that vacation leave, the employee must immediately request the use of sick leave by contacting the Chief or designee. Such requests may be made by telephone, email, fax or letter. No sick leave will be credited unless supporting medical evidence verifying that the illness or injury would have precluded working, is presented to the City by the employee or the employee's representative within a reasonable time of making the sick leave request, but in no event not more than ten (10) days after making the request.
- **E.** Employees covered under this Agreement will have the option to donate 100 hours of sick time to a fellow employee who shall require a recovery period from serious illness, operation or medical procedure which will go beyond that of the employee's accumulated sick leave.

ARTICLE VI

BEREAVEMENT LEAVE

- A. The employee shall have up to three (3) days leave with pay in the event of the death of an employee's Spouse, Child, Parent, Step-parent, Step-child, Sibling, Step-brother or sister, Brother-in-Law, Sister-in-Law, Mother-in-Law, Father-in-Law, Son-in-Law, Daughter-in-Law, Grandparents or Grandchildren.
- B. One (1) day of leave with pay shall be granted for aunts, uncles, nieces and nephews.
- C. Each employee shall have three (3) days of bereavement leave for other family members not listed above who reside in the same household as the employee on the date of the relative's death.

ARTICLE VII

ADMINISTRATIVE/PERSONAL LEAVE

- **A.** Employees covered by this Agreement shall be entitled to administrative/personal leave in a calendar year as follows:
 - 1. Each employee who has worked for the City for a full twelve (12) months shall be eligible for four (4) paid administrative/personal leave days, which shall be credited on January 1st of the calendar year.
 - 2. Newly hired employees shall be credited on their anniversary date of one full year of service with a prorated portion of administrative/personal days carrying them to the end of the calendar year.

The employee shall be credited the full four (4) administrative/personal days on the 1st of the January following the year in which the credit was earned.

- 3. Administrative/Personal leave may be used for emergencies, the purpose of conducting personal business and/or family duties or for the observation of religious or other days of celebration (excepting holidays). The use of such administrative/personal shall require a minimum of forty-eight (48) hours notice to the Chief or his/her designee. In case of any unforeseen circumstances and/or emergency, the notification requirement may be waived, suspended or altered upon approval of the Chief or his/her designee.
- 4. Unused administrative/personal leave days remaining in any year shall be converted into vacation days for the succeeding year.
- 5. Where there are more requests for administrative/personal leave than can be granted, the conflict will then be resolved on the basis of seniority. The maximum number of such requests shall be granted provided they do not interfere with the proper conduct of City business.

ARTICLE VIII

GRIEVANCE PROCEDURE

- A. For the purpose of this Agreement, a grievance is defined as a claim based upon a breach, misinterpretation or improper application of the terms of this agreement.
- **B.** The purpose of the following procedure is to secure, at the lowest possible level, equitable solutions to such problems arising from time to time affecting members of the bargaining unit. Both parties agree that these procedures will be kept informal and confidential as may be appropriate at any level of the procedure.
- C. Whenever a grievance arises, the following procedures shall be followed:
 - 1. An aggrieved employee shall institute action under the provisions hereof within fifteen (15) days from the date of the occurrence of the breach, misinterpretation or improper application of the terms of this Agreement. Failure to act within said fifteen (15) day period shall deem to constitute an abandonment of the grievance.
 - 2. **LEVEL ONE:** An employee with a grievance shall first discuss it with his/her immediate supervisor either directly or through the appropriate bargaining unit representative with the objective of resolving the matter as expediently as possible. The immediate supervisor's decision must be rendered within fourteen (14) calendar days from the date the grievance was received.
 - 3. **LEVEL TWO:** If the aggrieved employee is not satisfied with the disposition of his/her grievance at Level One or if no decision has been rendered within fourteen (14) calendar days after the grievance was delivered at Level One, the aggrieved employee may, within seven (7) calendar days after a decision, or twenty-one (21) calendar days after the grievance was delivered at Level One, whichever is sooner, submit the grievance to the Department Director.

The Department Director's decision must be rendered within seven (7) calendar days from the date the grievance was received at Level Two.

4. **LEVEL THREE:** If the aggrieved employee is not satisfied with the disposition of his/her grievance at Level Two, the aggrieved employee may submit his/her grievance to the Board of Commissioners. The Board of commissioners shall review and consider the submitted grievance and shall issue a decision within fourteen (14) calendar days after receipt of the grievance.

ARTICLE IX

MEDICAL AND PRESCRIPTION COVERAGE

A. HEALTH COVERAGE

The City shall provide to each fulltime employee and the employee's dependent family members medical health coverage and prescription drug benefits as provided for under the New Jersey State Health Benefits Program as administered by the Department of Treasury, Division of Pensions and Benefits in accordance with New Jersey State Law. The City is not responsible for any difference between coverage or co-pay changes made by the State under the New Jersey State Health Benefits Program. Changes made by the State are the responsibility of the employee.

A health contribution amount to offset the annual cost to the employee for medical and prescription benefits will be provided through the payroll health deduction process in the following amounts:

2021: \$1,600

2022: \$1,700

2023: \$1,800

2024: \$1,900

The City may, in its discretion, change providers for medical and prescription drug coverage provided the coverage is equal to or better than the NJ State Health Benefits Program. Any employee retiring from the City of Bordentown with thirty (30) years of service and attaining at least 62 years of age or older shall have the opportunity to remain in the medical insurance plan and be entitled to City paid health coverage (Single or Employee/Spouse ONLY) less the retiree's contribution as required by the State of New Jersey PL 2011, Ch. 78. Any such employee must enroll in Medicare Part B when eligible as the primary insurance coverage.

Any employee hired on or after January 1, 2017 will not be eligible for paid health benefits at the time of retirement.

B. VISION COVERAGE

Employees covered under this Agreement, their spouse and dependents shall be entitled to reimbursement of vision expenses in the following amounts with a paid receipt provided by the employee as proof of services rendered by a professional for vision services, insurance premiums and appurtenances. (i. e. prescription eyeglasses, sunglasses, contact lenses, etc.) Medical Insurance co-pays are not considered as reimbursable under this Article.

2021: \$900

2022: \$1,000

2023: \$1,100

2024: \$1,200

C. DENTAL COVERAGE

Employees covered under this Agreement, their spouses and dependents shall be entitled to Dental Health Coverage at no cost to the employee.

Health coverage, prescription drug coverage, dental coverage and vision coverage (as provided in this article) shall continue in full force and without interruption during the period of time that an employee is on workers' compensation leave and/or FMLA.

ARTICLE X

UNIFORMS

- **A.** The City of Bordentown will issue the following:
 - 3 long sleeve shirts
 - 3 short sleeve shirts
 - 3 trousers
 - 1 police service coat
 - 1 2-pocket black BDU shirt
 - 1 pair black BDU trousers
 - 1 raincoat and hat cover
 - 1 police hat and hat badge
 - 1 black baseball hat
 - 1 winter hat
 - 1 set of collar brass
 - 1 name tag
 - 1 flashlight
- **B.** An annual uniform and maintenance allowance will be paid to every full-time Public Safety Officer in accordance with the schedule as set forth below:

2021: \$2,075

2022: \$2,125

2023: \$2,175

2024: \$2,225

Said uniform allowance shall be paid within twenty (20) days of final passage and Adoption of the Municipal Budget.

Newly hired Public Safety Officers issued uniforms upon hire, shall not receive uniform/maintenance during their first partial year and will only receive 50% of the listed amount during their first full calendar year.

ARTICLE XI

EMERGENCY MEDICAL TECHNICIAN

A. Employees having and maintaining Emergency Medical Technician (E.M.T.) Certification shall receive an annual stipend as stipulated below:

2021: \$1,000

2022: \$1,050

2023: \$1,100

2024: \$1,150

ARTICLE XII

EMERGENCY MEDICAL SERVICE-AMBULANCE

An **annual stipend of \$12,000** shall be payable to the designated EMT under the EMS Shared Services Agreement with the Township of Bordentown. Said stipend shall be in addition to the regular base salary and paid with the bi-weekly payroll of the employee.

Said stipend shall be included as pensionable income for the designated employee until termination, retirement, or resignation.

ARTICLE XIII

WAGE ADJUSTMENT

A. Wage adjustments for the duration of this agreement shall be as follows:

2021: 3%

2022: 3%

2023: 3%

2024: 3%

ARTICLE XIV

LONGEVITY

Each employee covered by this Agreement who has accumulated fifteen (15) years of service with the City shall receive a longevity payment in the amount of \$1,200 per annum for the duration of this agreement.

Longevity payments shall begin on the employee's anniversary date of hire and shall be prorated on the basis of the percent of remaining time in that year. Longevity payments shall be paid before December 31st and shall not be considered part of the employee's pensionable base salary.

ARTICLE XV

JOB ADVANCEMENT AND EDUCATION

- **A.** Job advancement shall be based on seniority years of service with the City. A candidate for job advancement shall be qualified for the position desired. Final approval will rest with immediate supervisory personnel and the Department Director.
- **B.** Each employee who has been employed by the City for at least five (5) years and who holds one of the following degrees from an accredited institution on January 1st of any year shall be entitled to a stipend which shall be paid in a check separate from any and all other checks within 20 days of the final passage of the City's budget for that year. These stipends are not cumulative, and the member must provide copies of their transcripts prior to March 31st to be eligible to receive the stipend.

Bachelors Degree: \$250 Master's Degree: \$500

ARTICLE XVI

AUTHORITY TO BARGAIN

The negotiating committee which is voted into office or appointed by the members of the bargaining unit shall have the power to approve and sign all negotiations or agreements when approved by a 51% majority of all permanent full time employees who are in attendance at any meeting of the bargaining unit that is called for the specific purpose of ratifying this Agreement. The terms and provisions of this Agreement shall be binding upon all permanent, full time Public Safety Employees and shall inure to the benefit of all persons who shall hereafter become employees of the City and are entitled to the terms of this Agreement.

ARTICLE XVII

FULLY BARGAINED AGREEMENT

- **A.** This agreement represents and incorporates the complete and final understanding and settlement by the parties of all bargainable issues, which were or could have been subject to negotiations.
- **B.** During the term of this Agreement, neither party will be required to negotiate with respect to any such matter whether or not covered by this Agreement and whether or not within the knowledge or contemplation of either or both parties at the time they negotiated this Agreement.

ARTICLE XVIII

DURATION AND AMENDMENT OF AGREEMENT

- **A.** This agreement shall become effective as of January 1, 2021 and shall remain in full force and effect as written until December 31, 2024 unless modified by mutual consent prior to the ending date. The terms of this agreement shall be retroactive to the effective date regardless of the actual date of final ratification by the parties. By mutual consent given by both parties prior to the expiration date, the terms of this contract may be extended beyond the expiration date while active negotiations for a new contract are in progress.
- **B.** This agreement may be amended at any time by mutual consent of the parties thereto. If the City desires to amend the Agreement, a written notice shall be presented to the current leadership of the employees or their duly appointed representative(s) requesting a meeting for the purpose of amending the Agreement. A written response from the employee is required within five (5) days. Likewise, if the employees desire to amend the Agreement, a written notice shall be presented to the City Clerk requesting a meeting for the purpose of amending the Agreement. A written response from the City is required within five (5) days. The notice to amend must state the part of the Agreement proposed to be amended and clearly set forth the proposed change(s). For the purposes of this section, only that part of the Agreement proposed to be amended shall be open for discussion. The remainder of the Agreement shall remain untouched.
