MEMORANDUM OF AGREEMENT

THE UNDERSIGNED REPRESENTATIVES OF BROOKDALE COMMUNITY COLLEGE AND F.O.P. LODGE #79, HAVING ENTERED INTO COLLECTIVE NEGOTIATIONS FOR A SUCCESSOR AGREEMENT TO THE 1978-1981 NEGOTIATED AGREEMENT, HEREWITH AGREE AND ARE AGREED AS FOLLOWS, SUBJECT TO RATIFICATION BY THE BOARD OF TRUSTEES AND THE F.O.P. MEMBERSHIP:

1. THE NEW AGREEMENT SHALL BE EFFECTIVE FROM JULY 1, 1981 THROUGH JUNE 30, 1982.
2. MINIMUMS AND MAXIMUMS FOR BARGAINING UNIT POSITIONS SHALL BE INCREASED BY 5% EFFECTIVE JULY 1, 1981 AS FOLLOWS:

3. SUBJECT TO APPLICABLE MAXIMUMS, BARGAINING UNIT MEMBERS SHALL BE GRANTED A SALARY INCREASE OF 9% EFFECTIVE JULY 1, 1981. IN THE EVENT THAT THE 9% INCREASE PROVIDED WOULD CAUSE AN INDIVIDUAL EMPLOYEE'S SALARY TO RISE ABOVE THE NEWLY ESTABLISHED MAXIMUM THE AMOUNT ABOVE THE MAXIMUM SHALL BE PAID AS A ONE-TIME PAYMENT AND SHALL NOT BE COMPUTED IN BASE.
4. THE PARTIES WILL FURTHER REVIEW PROPOSALS CONCERNING PROBATIONARY STATUS UPON RATIFICATION OF THIS MEMORANDUM.
