ADDENDUM TO THE CONTRACT BETWEEN TEAMSTERS UNION LOCAL 469 AND THE TOWNSHIP OF WASHINGTON, MORRIS COUNTY

WHERAS, the Governor has ruled that all state and local municipal government employees must contribute 1 ½% of their salaries towards their health benefit premium effective May 21, 2010 or after the expiration of any binding Union contracts. Although exempt under the terms of their contract until the December 31 2011, expiration date, the Teamster's Union Local 469 has agreed to contribute 1 ½% of their salary towards their health benefits starting May 21, 2010.

IN CONSIDERATION OF good labor relations, it is agreed that Teamsters Union Local 469 will be exempt from any lay offs until December 31, 2011.

IT IS FURTHER UNDERSTOOD that this addendum voids and replaces Article 13 Section H. and now becomes part of the January 1, 2008 – December 31, 2011 contract.
