ARTICLE I

RECOGNITION

The Board hereby recognizes the Association as the exclusive and sole representative for collective negotiations and conditions of employment for all part-time night school instructors under contract by the Board.

ARTICLE II

TEACHER EMPLOYMENT

- New employees shall be placed on the salary guide at a level acceptable to them and the school district.
- Employees will be issued contracts by September 1st of each year. Discontinuation of employment shall be made in writing.
- 3. Full-time staff members who are responsible for a shop area shall be given the courtesy of first option on night school positions in their area.
- 4. The Association will supply a list of officers to the Board by October 1st of each year.

SALARY GUIDE

CLASS I INSTRUCTORS

These positions are defined as those needed for a trade, industrial and vocational education. To include persons who, in addition to classroom theory, must supervise equipment or practical application of theory in a shop or instruct persons who will use this skill for a livelihood.

#### LETTER OF AGREEMENT

#### 1979-80 and 1980-81 SCHOOL YEARS

The Board and the Association agree to give employment priority to those instructors who were teaching in September 1978. The night school Director and the President of the Association shall settle any dispute as to employment for this school year. The Superintendent of the district shall be the final arbitrator.

#### DURATION OF AGREEMENT

THIS AGREEMENT shall be effective as of September 1, 1979, and shall continue in effect until August 30, 1981.
