- A. No credit shall be given for coaching experience outside of the Hamilton Township Public School System.
- B. The salaries of new coaches shall be based on the zero experience level.
- C. An additional year of coaching experience will be given for each year beyond the 1968-69 school year for experience in the Hamilton Township School System in the same sport and category, until the maximum is reached.
- D. Any coach appointed to a different sport or category will start at the zero experience level.

VI. DURATION OF AGREEMENT

This agreement shall become effective on September 1, 1969, and shall continue in force until June 30, 1973. Negotiations for the period of this agreement shall not be reopened during the life of this agreement. Negotiations for any subsequent agreement to take place beyond June 30, 1973, may commence on or about November 1, 1972.
