AMENDMENTS TO THE 1975 LABOR AGREEMENT

1. The 1976 pay ranges for job classifications covered by this agreement are set forth below:

Senior Boy's Supervisor \$8,203 - \$13,530

Boy's Supervisor \$7,086 - \$11,714

Girl's Supervisor \$7,086 - \$11,714

- 2. All employees covered by this Agreement will receive a salary increase on their respective anniversary date (for pay purpose only, January 1 for all employees hired prior to January 1, 1972 and one year from date of hire for all employees hired on or after January 1, 1972.) Based upon their annual salary as of December 31, 1975 as set forth below:
 - a. 1975 annual salary 0 \$10,000: 6 percent on their annual base to a maximum of \$600.
 - b. 1975 annual salary \$10,001 \$15,000: \$600 plus 4 percent of the difference on the annual base over \$10,000 to a maximum of \$200.

All employees covered by this agreement who have a January 1 anniversary date will receive their salary increase retroactive to January 1, 1976. All other employees will receive their increases effective on the first day of the first full pay period following their anniversary date of hire.

- 3. The County agrees to provide a \$1 co-payment prescription drug plan for all employees covered by this Agreement.
- 4. Employees having completed five (5) years of continuous service will have added to their gross per annum pay an additional \$200 commencing with the first day of the first full pay period following said anniversary of hire, and for the completion of each additional five (5) years of service calculated in the same manner using employee anniversary dates, shall have added to their gross per annum pay, an additional \$200.
- 5. The County agrees to provide an annual \$75 clothing maintenance allowance payable in

December each year. Uniforms will be replaced on an as needed basis at the discretion of the Youth House Superintendent.
