ADDENDUM I

Addenda to the Agreement entered into the 19th day of April, 1973, by and between the Watchung Borough Board of Education, hereinafter called the "Board" and the Watchung Borough Education Association, hereinafter called the "Association".

ARTICLE IX SALARIES

Replace Paragraph A.5 with the following statement:

5. All teachers shall be given notification of renewal or non-renewal of contract for the following school year no later than March 30th of each year, except that teachers employed after January 1st shall be given such notification no later than April 30th, and the teachers shall thereafter notify the Board of intention to accept or reject such contract, if offered, within two weeks after receipt of such notice.

ARTICLE XI PROFESSIONAL IMPROVEMENT

Replace Paragraph B with the following statement:

B. Any teacher desiring to take any course(s) for this own professional improvement shall be reimbursed for tuition, which reimbursement shall not exceed the rate charged by New Jersey public institutions of higher education, for such course(s) under the following conditions.

ARTICLE XIV EXTENDED LEAVES OF ABSENCE

Replace Paragraph C.1-5, Maternity Leave, with the following statement:

C. Maternity Leave

1. A teacher may request a leave of absence for maternity, without pay, and such leave shall be granted by the Board subject to the procedures, conditions and provisions specified by the Order of the Division of Civil Rights entered in Miller v Pequannock Bd. Ed., et als, Docket No.E14 ES 5422.
