The undersigned, being representatives of their respective organizations known as the HAZLET TOWNSHIP BOARD OF EDUCATION; hereinafter referred to as the Board, and the HAZLET TEACHERS ASSOCIATION; hereinafter referred to as the Teachers; do hereby agree to the following covenants:

- 1. Salaries for the 1973-1974 and 1974-1975 shall be as agreed to in the attached salary guides.
- 2. The maternity clause of the present contract shall be re-written to terminate the maternity leave nine (9) months after delivery or miscarriage.
- 3. The Sabatical Leave provision shall be re-written to read "The Superintendent may recommend" and there shall be added the clause "The Board may grant such leave at it's sole discretion."
- 4. The clause on credit for previous service shall be re-written to express the following intent:

A new employee with previous experience shall be placed on the guide at a step not to exceed A5, B5, C5, D5, E5 or F5 according to his or her qualifications, however, the Superintendent may recommend to the Board, the hiring of a new teacher at a step in excess of the five year experience award. The granting of which shall be at the sole discretion of the Board.

- 5. Credit for approved courses shall be increased to 9 credits (\$270.00) but not to exceed a total of \$270.00.
- 6. It is agreed by and between the parties that this agreement shall become part and parcel of the over-all agreement and shall be made a part thereof as though the entire agreement on Terms and Conditions of employment appeared herein.
- 7. It is agreed by and between the Board and the Teachers that this agreement shall commence on July 1, 1973 and end on June 30, 1975.
