MEMORANDUM OF AGREEMENT CAFETERIA MANAGERS

The Board of Education agrees to provide the following for the return of services for the district's cafeteria managers.

- 1. Health benefits parity with teachers, secretaries.
- 2. Work week shall be no less than thirty-five hours per week.
- 3. The work year shall be one hundred eighty-four days, and any days beyond one hundred eighty-four shall be compensated by compensatory time.
- 4. Leaves of absence.
 - a. In conformity with Chapter 142, P.L. 1942, full-time employees shall be allowed ten (10) days sick leave with full pay in any school year. After ten (10) years of service within the Point Pleasant school system, employees shall receive twelve (12) sick days which shall be cumulative.
 - b. Personal days three days.
 - c. Five bereavement days for first degree relative.
 - d. One bereavement day for second degree relative.
- 5. Retirement benefit.

Same as secretaries.

6. Uniform allowance.

\$200.00 annual uniform allowance.

7. Salary.

Each manager shall receive a 4.9% increase each year of the contract.

8. Longevity.

In-service payments will be added after completion of seven, ten and fifteen years as follows:

| Completion of 7 years but less than 10 years | \$300 |

| Completion of 10 years but less than 15 years | \$500 |
| Completion of 15 years | \$700 |

9. Duration of Agreement.

This Agreement shall be effective as of September 1, 2005 and shall continue in effect until June 30, 2008. This Agreement shall not be extended orally and it is expressly understood that it shall expire on the date indicated.
