

**MEMORANDUM OF AGREEMENT
WITH WASHINGTON TOWNSHIP
SUPERIOR OFFICERS' ASSOCIATION**

THIS MEMORANDUM OF AGREEMENT has been entered into by and between the TOWNSHIP OF WASHINGTON (the "Township") and Washington Township Superior Officers' Association ("S.O.A.") for the purpose of memorializing the parties' agreement to amendments to the collective bargaining agreement for the S.O.A. bargaining unit. The current collective negotiations agreement expires on December 31, 2017.

The parties will continue to adhere to the terms and conditions set forth in the previous agreement for the period of January 1, 2014 through December 31, 2017, with the following amendments:

EMT STIPENDS:

Beginning in 2016, each officer certified as an EMT before January 1 of the current year shall receive an annual \$500 stipend. Each officer certified as an EMT between January 1 and July 1, shall receive a stipend of \$250 for the current year.


CONTRACTOR'S RATE:

In lieu of any overtime or other payment, employees will be paid at the flat rate of \$70.00 per hour for a minimum of four hours for "Contractors" work, *i.e.*, outside employment by independent entities other than the Township, that is scheduled through the Township and reimbursed to the Township by the Contractor. The Township rate for use of the police vehicle and administrative costs will be an additional \$27 per hour. These rates will be effective April 1, 2016.
