ADDENDUM AGREEMENT

between

PASSAIC COUNTY BOARD OF CHOSEN FREEHOLDERS

and

PASSAIC COUNCIL #3
NEW JERSEY CIVIL SERVICE ASSOCIATION, INC.

for

REGISTERED PROFESSIONAL NURSES and
LICENSED PRACTICAL NURSES

at

PREAKNESS HOSPITAL

This Agreement entered into by and between the Board of Chosen Freeholders of Passaic County (hereinafter referred to as the "Employer") and Passaic Council #3 (hereinafter referred to as the "Council").

WHEREAS the parties did negotiate and did reach general agreement for the contract years 1973 and 1974, and

WHEREAS the Agreement reached between the parties for years 1973 and 1974 did provide for a contract reopener for the purpose of securing further economic adjustments for the second year of the Agreement, and

WHEREAS agreement was reached as between the parties for the year 1974 covering the above subject, and

WHEREAS the parties desire to memorialize the results of said negotiations,

NOW, BE IT RESOLVED that the following shall constitute the Agreement:

RATE OF PAY

Effective and retroactive to January 1, 1974, the salary of the nurses covered by this Agreement shall be as set forth below, subject to corrections for subsequently discovered errors by either of the parties.
