

**AMENDMENT TO THE BOROUGH OF  
SOUTH RIVER PBA LOCAL 62  
COLLECTIVE BARGAINING AGREEMENT**

The Borough of South River PBA Local 62 Collective Bargaining Agreement shall be amended to provide for the inclusion of the South River Superior Officers to the contract. It shall be a contract term from January 1, 2006 until December 31, 2009. All terms to this Amendment are retroactive to January 1, 2006.

Article I

RECOGNITION

B. The bargaining unit shall consist of all Superior Officer's of the Police Department of the Borough of South River, New Jersey, now employed or hereinafter employed, excluding the Patrolmen, Deputy Chief of Police and the Chief of Police. For the purposes of this Agreement the terms Superior Officer, employee or employees shall refer to all members of the bargaining unit as defined herein. This Agreement shall govern all wages, hours, and other terms and conditions of employment herein set forth.

Article XIII

WORK SCHEDULE AND OVERTIME

B. When it becomes necessary for personnel to be called out on emergency, such personnel shall be compensated at time and one half the employee's base hourly rate with a four (4) hour minimum guarantee.

Article XVI

HEALTH AND LIFE INSURANCE

B. (4). At the time of retirement, no dental insurance shall be offered or available to the retired Superior Officer by the Borough.

Article XVIII

HOLIDAYS

C. Superior Officer's working hours and schedules shall not be reduced for any holidays.

NEW - Holiday pay will be for all 12 days in the contract and will be handled similar to the PBA contract.

Article XIX

SICK LEAVE

V. (4). For all sick leave accrued by any employee prior to January 1, 1978, an employee shall be eligible to be paid on a basis of one (1) sick day for every four (4) sick days accrued.

W. All employees hired subsequent to October 1, 1980 shall be entitled to sick day benefits as set forth herein, but shall also be limited to a maximum of one hundred thirty (130) accumulated sick days. Starting January 1, 2006, the sick time allowance will increase to one hundred and eighty accumulated sick days. Any lost back time will not be included.

Article XXI

PERSONAL DAYS

A. Starting January 1, 2007, personal days shall be increased to seven (7) days per year.

B. In addition to salaries, all members shall receive longevity as follows:

Zero to six years	0.0%
Six years to ten years	3.0%
Ten years to fifteen years	5.0%
Fifteen years to twenty years	7.0%
Twenty or more years of service	9.0%

Longevity shall be included in the base salary for the purpose of calculating pension benefits.

TERMINAL LEAVE (NEW)

Terminal leave shall be provided in the same manner as provided for in the Borough Code of the Borough of South River as of January 1, 2006.

All other terms not contained in this addendum shall be governed by the existing collective bargaining agreement between the Borough of South River and the South River PBA Local 62.




