### **MEMORANDUM OF AGREEMENT**

The negotiation committees of the Pequannock, Lincoln Park and Fairfield Sewerage Authority and the United Public Service Employees Union - New Jersey Division hereby agree to recommend to their respective constituents a year extension of the existing agreement. The terms for a successor collective negotiations agreement are as follows:

- 1. Article XXIX (Term and Renewal) January 1, 2015 through December 31, 2015.
- 2. Article XX (Wage Increases and Merit Pay) Effective January 1, 2015, those employees in the bargaining unit who have been employed by the Authority for one (1) year or more, shall receive an additional 2.5% pay increase.
- 3. Effective January 1, 2015, Union members shall receive a non-pensionable, non-compoundable onetime payment of \$250.00, which shall not be added to the base salary. This is a onetime payment and shall not continue in any subsequent year.
- 4. The terms of this Memorandum of Agreement are subject to ratification by the full membership of the United Public Service Employees Union New Jersey Division and the Pequannock, Lincoln Park and Fairfield Sewerage Authority.
- 5. All proposals which are not included in this Memorandum of Agreement shall be deemed withdrawn by both parties.
- 6. The existing collective negotiations agreement shall remain in effect except as modified above.
