If you are unable to provide your contracts in one of these word processing formats, we will accept them in pdf format, or photocopied single sided and mailed to the agency PO Box.

Employers must redact all contracts to comply with the privacy provisions of the Open Public Records Act, N.J.S.A. 47:1A-1 et seq. and must exclude confidential personal information such as social security numbers. Please note that individual employment contracts should not be filed.

You must include in your email the text of the attached certification with the name and title of the appropriate government official.
