

THE COMMUNICATIONS WORKERS OF AMERICA AFL-CIO

MEMORANDUM OF AGREEMENT

The Township of Mount Laurel (“Township”) and the Communications Workers of America AFL-CIO, Clerical Employees (“Union”) on this 8th day of July, 2021 hereby agree to the following changes noted in relevant parts below to their collectively negotiated agreement which is set to expire on December 31, 2022. All other provisions of said agreement not expressly referred to herein remain unchanged.

**ARTICLE III
SALARIES**

All employees covered by this Agreement who are on a salary basis or hourly basis shall receive the following increases which shall be added to their hourly rate. Longevity is included in the hourly rate:

2021: 1.9% increase effective January 1, 2021. Minimum salary increased to \$30,000.00, effective July 5, 2021.

2022: 1.9% increase effective January 1, 2022.


