

**Memorandum of Agreement  
Between  
The Township of West Orange  
and  
West Orange PBA Local 25  
August 9, 2022**


The negotiation committees of the Township of West Orange, New Jersey and West Orange PBA Local 25 (PBA) agree to the terms of this Memorandum of Agreement, as set forth below.

All other language in the contract that expires December 31, 2022 shall continue in the new contract and will remain the status quo except the following:


1. Duration: January 1, 2023 through December 31, 2023
2. All base salaries will increase by 3% effective January 1, 2023 (see attached salary guide).
3. The parties acknowledge that these terms and conditions are subject to ratification.
4. All parties agree to recommend these terms and conditions to their respective constituents for ratification.
5. All issues agreed to herein shall be incorporated in the new agreement.
6. All issues not mentioned herein are withdrawn for consideration in this agreement except as set forth in paragraph 8, below.
7. All other terms and conditions of the parties 2018-2022 CNA remain in effect in 2023.
8. The terms of this MOA shall not impact or otherwise apply to any and all grievances, unfair practice charges, appeals or other matters currently pending, which shall include but not be limited to the ongoing grievance proceeding before Arbitrator Gwin and/or the Unfair Practice Charges docketed at PERC as CO-2023-010 and CO-2023-011, which, among other things, demand negotiations regarding on-call compensation and terms.
